## RESOLUTION TO APPROVE LABOR AGREEMENT BETWEEN MATC AND LOCAL 587, AFSCME, AFL-CIO

WHEREAS, the Milwaukee Area Technical College District Board has entered into negotiations with Local 587, AFSCME, AFL-CIO, an affiliate of Milwaukee District Council No. 48 (hereinafter "Local 587"); and

WHEREAS, the Board representatives have reached a tentative two-year agreement (March 7, 2011- March 6, 2013) with representatives of Local 587; and

WHEREAS, Local 587 has ratified the tentative labor agreement on March 3, 2011; and

WHEREAS, the Board has reviewed the terms and conditions of said agreement; therefore,

BE IT RESOLVED, that the Milwaukee Area Technical College District Board hereby accepts and approves the agreement reached by MATC and Local 587 bargaining unit, and authorizes signatures representing the MATC District Board and the Administration on the approved agreement, at which time said agreement shall be incorporated by reference to this resolution.
