MILWAUKEE PBS (FORMERLY MILWAUKEE PUBLIC TELEVISION) IS OWNED AND OPERATED BY THE MILWAUKEE AREA TECHNICAL COLLEGE. THE FOUNDATION ADMINISTERED \$5,856,318 IN CONTRIBUTIONS FOR MILWAUKEE PBS AND DISBURSED \$5,737,138 IN PROGRAM SUPPORT, A DECREASE OF 0.8% OVER THE PRIOR YEAR.

THE FOUNDATION AWARDED \$647,356 IN SCHOLARSHIPS AND EMERGENCY STUDENT ASSISTANCE GRANTS TO 728 STUDENTS. THIS REFLECTS AN INCREASE OF 3.4% IN DOLLARS AWARDED OVER THE PRIOR YEAR AND CONTINUES A SEVEN YEAR TREND OF INCREASED STUDENT SUPPORT.

THROUGH GRANTS IT RECEIVED DURING THE FISCAL YEAR AND PRIOR YEARS, THE FOUNDATION PROVIDED \$879,348 IN SUPPORT FOR MATC PROGRAMS, INCLUDING REV UP/AL HURVIS TRANSPORTATION CENTER, THE EXPANSION OF THE NURSING PROGRAM, AND AN INITIATIVE TO HELP IMPROVE THE TRANSITION OF STUDENTS FROM HIGH SCHOOL TO COLLEGE. THIS REPRESENTS A 325% INCREASE OVER THE PRIOR YEAR'S PROGRAM SUPPORT. IN ADDITION, THE FOUNDATION SERVED AS THE CONDUIT FOR \$63,093 OF IN-KIND DONATIONS OF MATERIALS AND EQUIPMENT FOR MATC'S PROGRAMS.
