Construction Renovation and Remodeling Projects

Part I: CONSTRUCTION Item 1: <u>RENOVATION AND REMODELING</u> DMC C Bldg. Data Center Improvements MATC Bid Reference #2021-010 – Project #2018879

Background Information

Previously, the Board approved lists of renovation and remodeling capital projects for budget years. The projects and funding plan were also approved as part of respective year budget approvals. The project deals with the renovation of the C building data center in the 3rd floor. This is considered phase 2 of 3. New electrical and mechanical rooms will be built out in the east & west adjacent spaces to provide redundant power & cooling for the data center. Part of the north side of the data center will now become storage & prep space for I.T.

This project will include upgrading electrical, digital controls for HVAC, plumbing & fire protection.

The contract recommended for approval below is for a single prime contract that pertains to the general construction for the previously mentioned areas.

Bid documents for the aforementioned work were prepared in accordance with Board policies and State regulations, and advertisements were placed in the Daily Reporter, the Milwaukee Courier and the Spanish Journal. The bids were opened on June 24, 2021 with the following results which include the Base Bid and Alternates 1,2,3,4,5 and 6.

Part I: CONSTRUCTION Item 2: <u>RENOVATION AND REMODELING</u> DMC Main Bldg. Steam to HW Conversion Phase 1 MATC Bid Reference #2021-007 – Project #2021101.02

Background Information

Previously, the Board approved lists of renovation and remodeling capital projects for budget years. The projects and funding plan were also approved as part of respective year budget approvals. This project deals with the start of converting MATC's heating system from steam to hot water in the Main Building. The first phase will consist of installing new piping infrastructure in the basement adjacent to the existing domestic water system and running risers up to the second floor and installing the piping loops to prepare for future heating to variable air volume boxes (VAV) in offices, classrooms, etc.

Included in phase 1 is the installation of the heat exchanger and to hot water pumps.

The contract recommended for approval below is for a single prime contract that pertains to the general construction for the previously mentioned areas.

Bid documents for the aforementioned work were prepared in accordance with Board policies and State regulations, and advertisements were placed in the Daily Reporter, the Milwaukee Courier and the Spanish Journal. The bids were opened on June 24, 2021 with the following results which include the Base Bid and Alternates 1 and 2.

Previously, the Board approved lists of renovation and remodeling capital projects for budget years. The projects and funding plan were also approved as part of respective year budget approvals. This project proposes to remodel the southwest portion of the S-Building third floor located at the Downtown Milwaukee Campus. This project will include a new commercial kitchen and publicly accessible food service lines and dining area. New floor, wall and ceiling finishes will be provided throughout.

New lighting will be installed along with updated HVAC equipment and building automation direct digital controls. New sprinkler heads to be installed and connected to existing fire protection systems.
